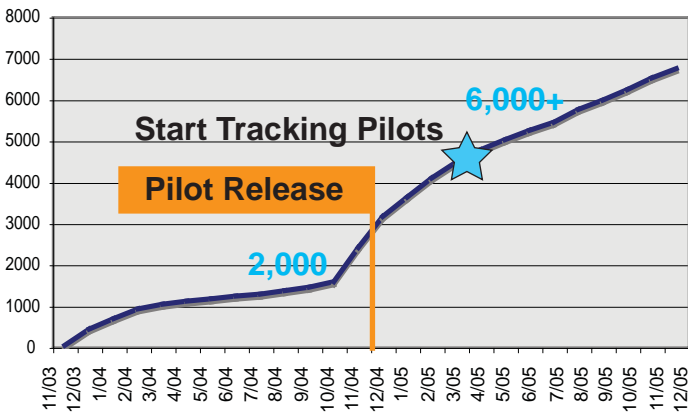
Green Guide Geographic Distribution

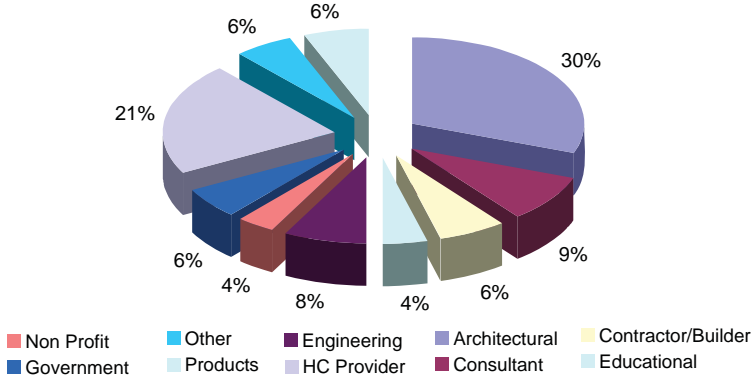


Registrants come from every state in the US.

Website Registrant Growth

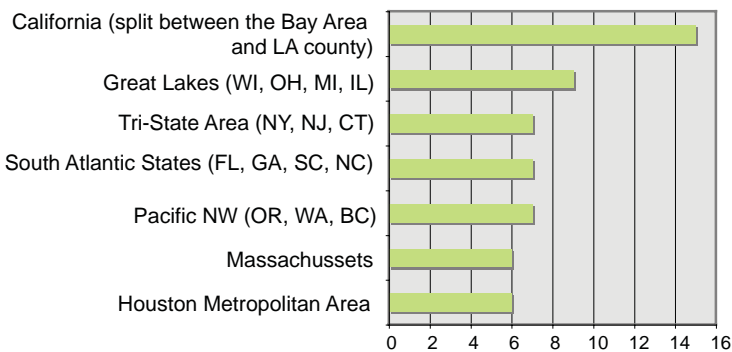


Green Guide for Health Care Website Registrants: Organizations

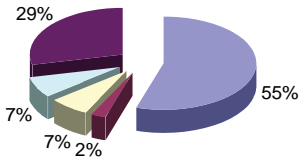

Green Guide Pilot Projects

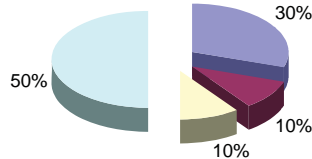

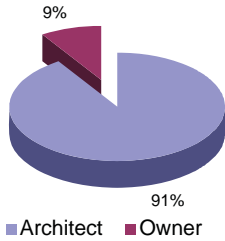

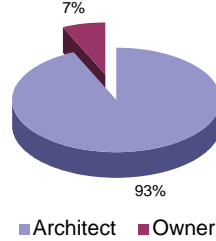
Renovation Projects



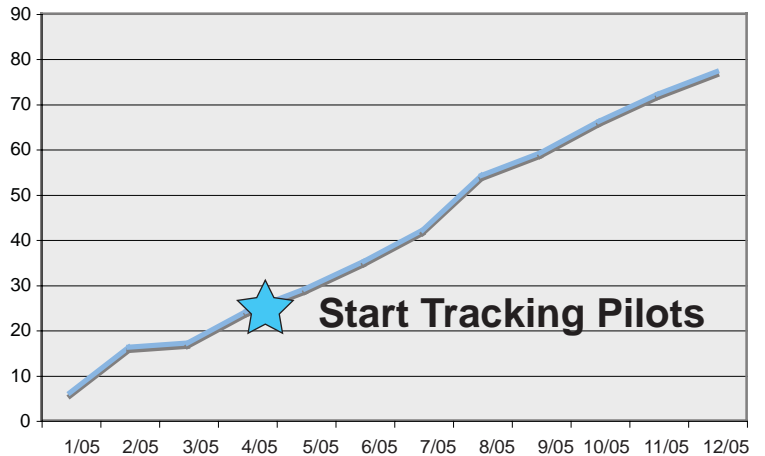

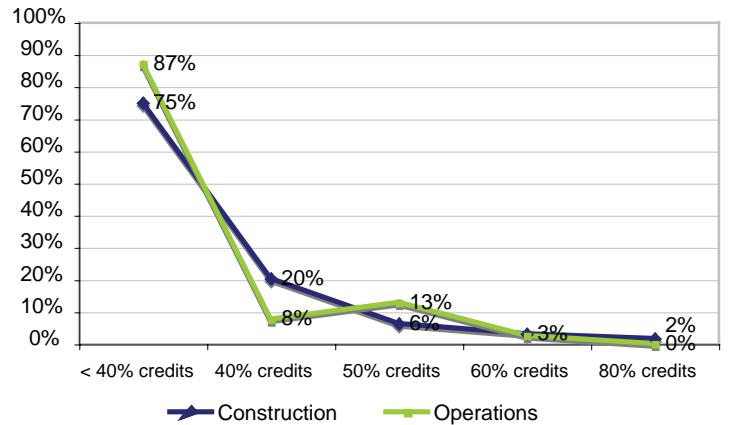

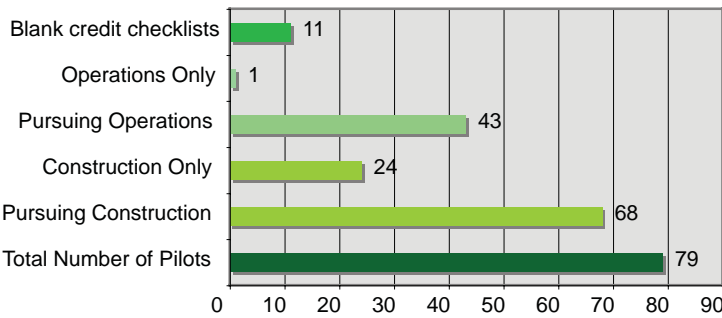
Pilot Growth 2005



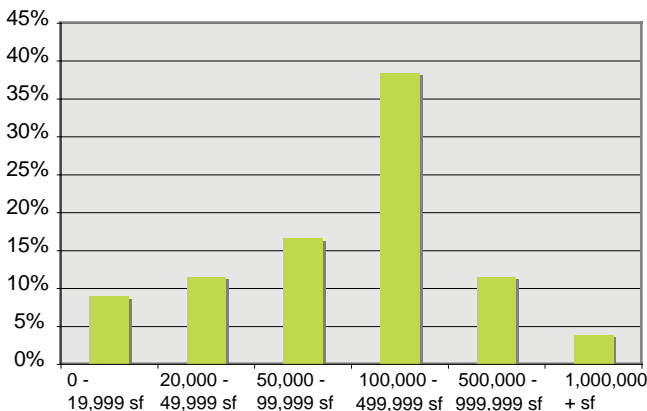

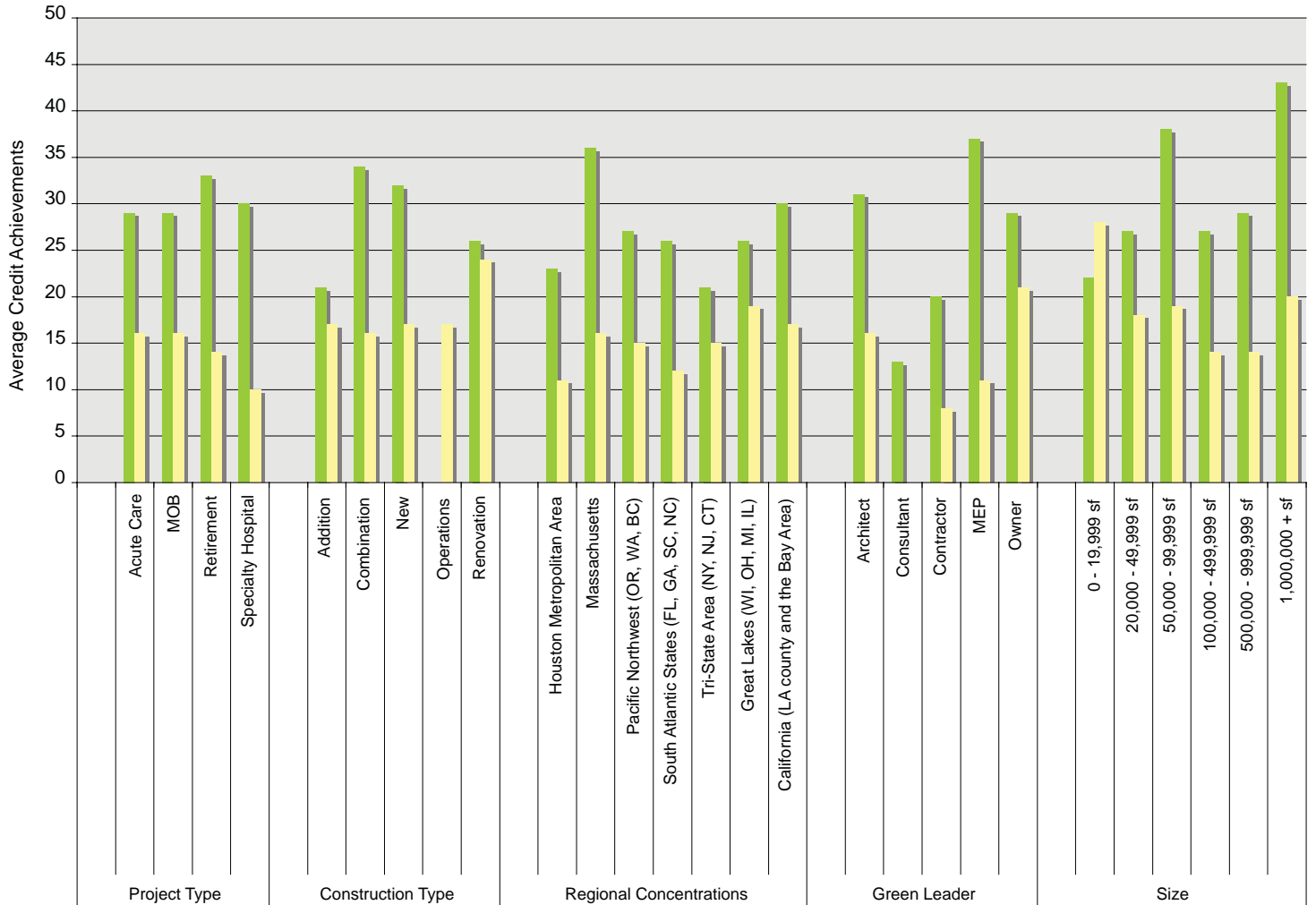
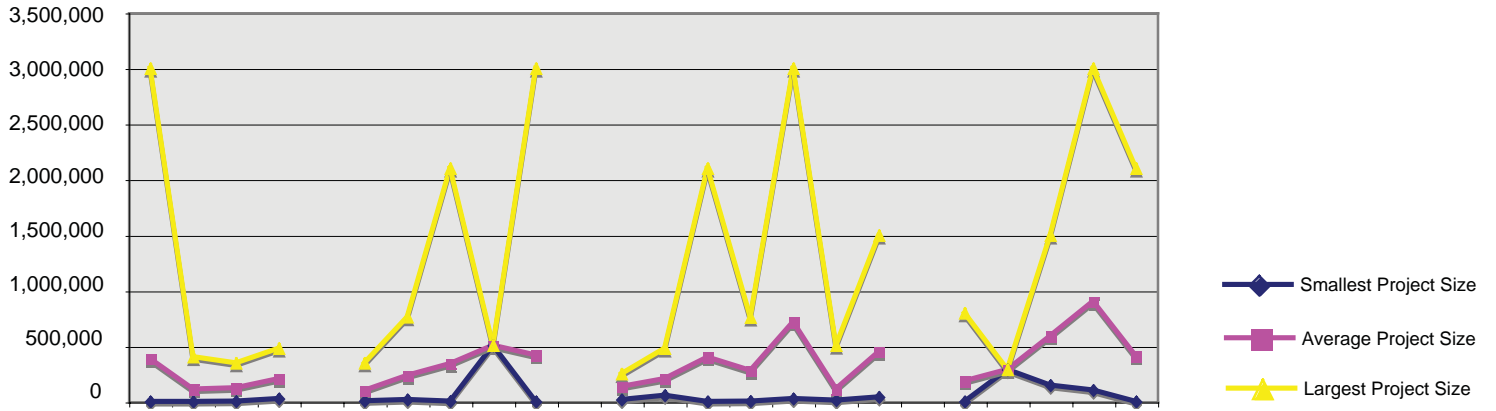
